Executive Summary

Introduction

This report pertains to data provided to the W.A. Aged Care Research & Evaluation Unit, on records of Home and Community Care clients and their carers, who received or were receiving one or more HACC services between the 1st July 2010 and the 30th June 2011. This version of the report includes updated data sets for all 4 quarters of the financial year 2010/11.

HACC Program

The HACC Program is a key provider of community care services to frail aged people and younger people with disabilities and their carers. The overall objective of the HACC Program is to maintain or improve the independence of people in these groups and to avoid or delay their premature admission to long term residential care through the provision of basic maintenance and support services.

HACC MINIMUM DATA SET (V2)

The data elements included in the HACC Minimum Data Set (MDS) and defined in the HACC National MDS User Guide Data Dictionary 2.0 are considered to be the minimum information requirements for reporting within the HACC program.

They relate to:

- The characteristics of care recipients (e.g. sex, age, indigenous status, functional status items)
- The circumstances of care recipients (e.g. where they live, whether they have a carer)
- The characteristics of carers (e.g. age, sex, indigenous status)
- Information about the service episode (e.g. source of referral, date of entry, date of last update)
- The assistance received by care recipients and carers from the HACC program (e.g. amounts and types of assistance received).



Classification of Regions



HACC Planning Regions and Subregions are classified according to the Statistical Local Areas (SLAs), based on the Australian Standard Geographical Classification by the Australian Bureau of Statistics. The client data is organised into SLAs and Subregions according to client residential postcode as recorded in the HACC MDS. The region classified as 'Others' includes postcodes which are missing, do not fall within any of the HACC planning regions, or relate to P.O. box addresses.

Data Preparation

The HACC MDS is reported to the National Data Repository on a quarterly basis. All clients receiving HACC services or stopped receiving services in the quarter will have at least one MDS record. Each client may have several MDS records in the period as they may be receiving services from several agencies.

There were 239,568 HACC MDS records in the 2010/11 HACC revised annual data set. Of those, 306 records did not have any assistance recorded and were excluded leaving 239,262 records.

A total of 239,262 records were aggregated to client level on the basis of the variable *SLK* resulting in **69,339** records used for the annual report.

It was observed before aggregation that many records of clients with multiple MDS entries had differing values for the same variable when two or more agencies were involved. It was decided, for the **purpose of comparisons with the 2009/10 HACC Annual Report**, to apply the **same aggregation rules as in the 2009/10 analysis** to determine the value of each variable used in the analysis:

- 1) The data were first **sorted by ascending SLK and Agency ID**.
- 2) Variables which by definition should have the same value if multiple records are present (i.e. *Country of Birth*, *Main Language spoken*, *Indigenous status*, *DVA*, *Pension status*)

The most frequent value was used; if the most frequent value was “missing” or “not stated” the 2nd most frequent value (if any) was used; if the most frequent value was “missing” or “not stated” as well as another value then the other value was used.
- 3) Variables which could have different values in multiple records (e.g. *Postcode*, *Living arrangements*, *Accommodation setting* could be different if a client moved; Carer details could be different if a carer stopped caring for a person during the year or if another carer took over; *Referral source*, *Reason for cessation* could be different in separate records)

The most frequent value was used; if the most frequent value was “missing” or “not stated” the 2nd most frequent value (if any) was used; if the most frequent value was “missing” or “not stated” as well as another value then the other value was used.
- 4) Carer exists

If this variable had a value of ‘Yes’ in one MDS record of a client with multiple records in the year, then it was assumed that that client had a carer regardless of other records indicating the opposite.
- 5) Functional status variables

The most frequent value was used; if the most frequent value was “missing” or “not stated” the 2nd most frequent value (if any) was used; if the most

frequent value was “missing” or “not stated” as well as another value then the other value was used.

6) Types of assistance variables

The values of each variable for various types of assistance were summed up to generate a variable composed of the total amount of each type of service received.

Clients were allocated to HACC Planning regions and subregions on the basis of their residential postcode which along with suburb/town is reported in the MDS (in the variable *Locality*). A total of 19 client records were found to have recorded missing or invalid postcodes but had a valid *Locality* name and thus were changed to reflect the correct postcodes.

In determining **Carers** and **Carers receiving HACC services** the following variables were used:

Comment:

Clients of the Home and Community Care Program consist of care recipients who are either older people or younger people with disabilities.

The HACC MDS records services provided to both care recipients and their carers. However not every care recipient has a carer and only a proportion of carers receive carer specific HACC services – Respite Care and/or Counselling, Support, Information and Advocacy.

The number of care recipients in 2010/11 increased by **3.4%** (**69,339** vs. 67,041 in 2009/10). The number of HACC clients who recorded having a carer also increased this year (**20,265** vs. 19,667 last year). However, the proportion and number of carers receiving carer specific services decreased to **20.7 %** from 23.8% in 2009/10 (**4,192** vs. 4,688 carers).



In 2010/11, **70.7%** of HACC clients were 70 years of age or older (**62.6%** in the 70-89 group and **8.1%** in the 90+), compared to the 2009/10 HACC report where 71.2% of HACC clients were 70 years of age or older (63.3% in the 70-89 group and 7.9% in the 90+). As with previous year's report, **10.8%** of HACC clients were younger than 50 years. This proportion remains similar to 2009/10 where 10.3% of HACC clients were younger than 50 years.

Comment:

Similarly to the 2009/10 HACC report, the Pilbara and the Kimberley regions have higher proportions of younger clients (ages 0 – 49).

Clients from ‘Other’ regions (includes regions ‘Not Stated’) recorded the highest proportion of clients with missing DOBs (**11.1%**), followed by clients in the Kimberley region at **7.4%**.

Comment:

More than half (**59.2%**) of all HACC clients were born in Australia, showing an increase of **0.8%** compared to the 2009/10 data. The highest proportion of non-Australian born clients were from Europe (**28.7%**), followed by Asia (**5.1%**). These figures were 28.8% and 5.2% respectively, in 2009/10. Like last year, there were a considerable number of records with missing COB recorded (**3.1%**).

Comment:

Most HACC clients reported English as the main language spoken at home (**88.1%**), increasing from 87.5 % in 2009/10.

Following that was European languages (**6.1%**), which included Southern European Languages (mainly Italian, Greek and French), Eastern European Languages (mainly Polish, Macedonian and Croatian) as well as Northern European languages (mainly German and Dutch).

Like last year's report, Kimberley, Pilbara and Goldfields recorded the highest number of HACC clients whose main spoken language was Australian Indigenous Languages – **395**, **155** and **150** clients, respectively, of a total 772 clients who recorded Australian Indigenous Language as their main language spoken.

The number of missing values was **2,009**, slightly lower than last year's 2,478.



Comment:

The percentage of HACC clients of Aboriginal and/or Torres Strait Islander background in 2010/11 was **3.6%**, a **0.1%** increase from last year. The majority of these (**74.0%**) were older than 50 years of age. The proportion of cases where indigenous status was recorded as 'not stated' decreased to **4.4%** compared to last year's 4.9%.

Comment:

As with last year's data, the highest number of ATSI clients amongst the rural and remote regions came from the Kimberley, Goldfields and Pilbara regions. The Kimberley region showed a **23%** increase in the number of indigenous clients (**652** vs. 530 clients in 2009/10), while the Goldfields and Pilbara regions recorded decreases of **24.4%** and **18.2%** respectively.

Within the metropolitan regions, the majority of ATSI clients were from the South East Metropolitan and East Metropolitan areas, which was consistent with last year's data.




Figure 3: Client Pension Status





Comment:

Amongst the assistance types provided by the HACC Program, Assessment, Domestic assistance and Transport registered the highest number of clients in 2010/11 with **38,064**, **28,821** and **19,504** clients respectively. However, when compared to last year's data, there were decreases of **13.5%** and **2.0%** respectively for Assessment and Transport and an increase of **6.0%** for Domestic assistance.

Home maintenance (**15,767** vs. 15,654 in 2009/10), Client care coordination (**15,575** vs. 20,112), Counselling, support, information and advocacy (**15,349** vs. 15,644), Social Support (**13,227** vs. 12,171), Centre-based day care (**12,172** vs. 12,086) and Meal services (**9,602** vs. 10,768) had the next highest numbers of clients.

For Counselling, support, information and advocacy assistance, **82.8%** were care recipients and the remaining **17.2%** carers.

Other assistance types included Nursing (**8,488** vs. 7,804), Personal care (**6,614** vs. 6,482), Allied health (**4,216** vs. 3,196), provision of goods and equipment (**3,469** vs. 3,943) and Respite care (**2,146** vs. 2,401).

The assistance types recording the lowest number of clients were the same as in 2009/10: Linen service, Home modification and Other food services with **30**, **185** and **269** clients respectively (53, 226 and 254 clients in 2009/10).



Comment:

The highest volume by hours of service provided to clients was for Centre-based day care, an average of **151.6** hours in the year (compared to 152.7 last year). The second highest average volume per client was **84.2** hours for Respite care (80.7 in 2009/10), followed by **49.5** hours for Personal care (51.3 hrs), **40.7** hours for Social support (42.5 hrs) and **29.4** hours for Domestic assistance (30.4 hrs). This year's 'highest volume by hours of service' order of ranking is similar to the 2009/10 HACC report. In actual average volume by hours there were slight decreases across most service types except for Respite care, Other food services, Home maintenance, Counselling/ support, information & advocacy for carers and Allied health.

The highest volume by quantity of services provided were, **96.9** Meals (vs. 92.3 in 2009/10), Transport **49.0** trips (48.2) and Linen services **10.8** units (10.6). The ranking was again consistent with the 2009/10 HACC report but the actual average amounts were higher.

For Home modification, which is recorded using actual costs (in dollars), the average cost for HACC clients who received this assistance type was **\$2,805**. This was more than double the average cost in 2009/10 of \$1,132.20.



Comment:

The number of assistance types received by HACC clients was calculated differently this year where Assessment was not included when counting the number of different assistance types received. Therefore, clients who only received an assessment were excluded.

Most clients received **one type of HACC service**, accounting for **40.3%** of the total HACC population.

This is followed by clients receiving two, three and four assistance types, with **24.0%**, **14.7%** and **9.4%** respectively.

Across WA, the total number of clients receiving seven or more assistance types decreased markedly from 6.0% in 2009/10 to **2.8%** this year. This is most likely due to the change in calculation methodology.


As with 2009/10, the highest proportion of HACC clients in every assistance type falls in the 70 to 89 year age group.

Within each age group the assistance types with the highest proportion of clients included Assessment (for all groups, except Not Stated), Domestic assistance, Client care coordination, Home Maintenance and Respite care. These figures were similar to 2009/10 when Assessment, Domestic assistance and Client care coordination contained the highest proportion of clients across all age groups.

Comment:

In 2010/11, a total of **14,823** clients ceased receiving services from the HACC program for various reasons; this was a decrease of **1.0%** compared to last year's report (or 149 clients less). The majority (**22.4%**) reported the reason for cessation was improved status where assistance was no longer required. This figure is higher than last year's report (21.0%). A further **8.5%** recorded not requiring assistance from that particular agency due to improved status (8.3% in 2009/10) but may have continued with a different type of assistance from another agency.

Other reasons for cessation of assistance included: reasons not specified (**14.2%**), client terminated service (**11.2%**), client died (**10.0%**), client moved to residential aged care (**9.2%**), client moved to other community based service (**8.1%**), client moved out of area (**4.2%**), client moved to other institutional setting (**3.0%**). There was a decrease in the proportion of clients who recorded that the agency was unable to provide assistance – **2.1%** this year compared to 2.4% in 2009/10. The remaining **7.1 %** of clients did not record a reason for cessation of HACC services, a decrease from 9.4% in 2009/10.

Comment:

Missing data for the variables *Postcode* and *Country of Birth* decreased by **0.02%** and **1.0%** respectively (0.03% and 4.1% in last year's report).

This year, missing data for the variable *Sex* was higher compared to the 2009/10 report (**0.12%** vs. 0.04%).

Missing data for client variables *Main Language*, *Indigenous status*, *Carer's DOB* and *Carer's Sex* were lower compared to 2009/10, decreasing by **0.8%**, **0.5%**, **0.3%** and **0.4%** respectively.


